



Mountain View Memorial Park 2018 Hanshik & Ching Ming Sweepstakes Terms & Conditions

1. **Eligibility:** This sweepstakes is open only to those who receive an entry form at the Mountain View Memorial Park Hanshik & Ching Ming event who are 18 years of age or older as of the date of entry. The sweepstakes is only open to legal residents of the United States, and is void where prohibited by law. You may enter only once. You must provide the information requested. You may not enter more times than indicated by using multiple entries, email addresses, identities, or devices in an attempt to circumvent the rules.
